#### **CLASS EXPECTATIONS**

- 1. Students must be in the classroom WHEN THE TARDY BELL SOUNDS. Each student is to set up his/her instrument, be seated, warmed-up, and ready to play by 3 minutes after the tardy bell.
- 2. Always speak to and treat your peers and the director with respect.
- 3. Woodson Orchestra is a safe place! Mrs. Thompson has a zero tolerance policy for bullying, discrimination and/or harassment based on race, color, religion, gender, national origin, disability, or sexual orientation.
- 4. No food, gum, or drinks are permitted in the classroom. Only water is allowed.
- 5. Students are to play only their own instruments! Do not "try out" other students' instruments. If you break it, you buy it.
- 6. Cell phones and other devices are off and put away during class or after-school rehearsals, except for authorized purposes (tuner/metronome).
- 7. Students are expected to keep their fingernails short. NO EXCEPTIONS! Long fingernails interfere with curving the fingers correctly to produce a quality sound.

#### **GRADING POLICY**

#### **Co-curricular Attendance**

The FCPS course description includes the following statement: Students must meet both the school day and outside of the school day participation requirements to receive credit for the course.

All orchestra students are expected to participate in after-school rehearsals and performances. We depend on every member of the group for our success. The mandatory rehearsals provide additional instructional time in preparation for performances, and often include sectional time to focus on instrument-specific concerns. After-school rehearsals are scheduled only when necessary, and a detailed calendar that notates the rehearsal schedule is released well in advance of the rehearsal.

**Excused** absences are accepted for the following reasons only:

- 1. Student illness
- 2. Family emergency
- 3. <u>Pre-arranged</u> absence at the discretion of the director

In order to earn a grade for an excused *rehearsal*, student must rehearse in the orchestra room within 1 week of his/her return to school. An additional assignment may be given.

Performances are one-time events and cannot be "made-up". However, a student will have one week upon returning to school to earn a grade for an <u>excused</u> <u>performance</u>. The student must perform his/her concert music for the director (in person or video recording); it will be reviewed and graded at the discretion of the instructor. An additional assignment will be given. It is the responsibility of the student to make-up the grade. The instructor <u>will not</u> "hunt you down". After 1 week, the grade becomes a zero. An unexcused concert absence will result in ineligibility for the orchestra spring trip.

Please schedule medical appointments for times other than after-school rehearsals or performances. Homework, sports practice, employment, or lack of transportation will not be excused absences. Teachers, coaches, and supervisors understand that orchestra is a class and these events are part of your academic requirements. They will work with you to ensure your success, IF you give them adequate notification. If you encounter problems, I will be happy to contact the appropriate individual in advance. <u>Do not wait until the last minute</u>.

#### **Quarter grade computation**

**Participation (50%):** Daily grade, preparedness, rehearsal etiquette, after school rehearsals You are expected to participate in class every day without exception. This means you must bring your instrument, music, pencil, and a willing attitude to class every day. You are awarded 10 points every class. Grades are based on participation and for following the criteria below.

The daily grade (10 points) will be based on the following categories:

- Prepared with instrument and equipment, music, and pencil every class.
- -Punctuality and readiness to play when the bells rings.
- -Understanding of the concept that music, to be properly performed, evaluated or rehearsed, must be rendered in an atmosphere of silence.
- -Attention to the conductor and an attitude of cooperation.
- -Alertness and readiness for the downbeat, including proper posture and hand position for the instrument.
- -Full participation in class.

#### Points will be deducted for:

- -Tardiness 3 points
- -Talking / Chewing Gum / Disruptive Behavior 2+ points
- -Lack of attention and/or poor posture 2 points
- -No instrument 8 points
- -No music 4 points
- -No pencil and/or proper equipment 3 points
- -Using someone else's instrument without permission 10 points and disciplinary action Unexcused absences cannot be made up, and will result in a zero for the day missed.

#### **Performance (40%):** Playing quizzes, tests and performances

- -Scales
- -Assigned exercises
- -Rehearsal preparedness
- -Seating auditions
- -Sight-reading
- -Playing quizzes & tests
- -Concerts

#### Class / Homework (10%): Written exercises, assignments, practice logs, etc.

- -Homework assignments
- -Class worksheets
- -Music theory papers
- -Practice logs, if assigned
