## Welcome to the 2014 Marching Statesmen

I'd like to welcome our new band students and parents to the family. We are happy you have chosen to join us and look forward to knowing you. The Marching Statesmen are a team. Together, we work hard to bring pride to ourselves, our school and our community. You will remember the camaraderie and teamwork you experience in marching band for the rest of your life. In this packet you will find all the information you need about marching band.

## Who is eligible to join?

All Marshall Band students are welcome and encouraged to be in marching band.
Instrumentalists: Marching band is co-curricular with Wind Symphony. Students in Wind Symphony are required to participate in Marching band unless they are playing a GCM fall sport. Concert band students are not required to march, but strongly encouraged.

Colorguard: Any GCM students interested in dancing, spinning flag, rifle and sabre are welcome in the colorguard. Workshops will be held this spring and summer. No experience is necessary to attend workshops.

## Summer Camp and After-School Rehearsals

Summer camp is required for all Marching Statesmen. It is essential for the success of our season that all performers attend all rehearsals. Remember, marching band is the ultimate team activity. Each individual is extremely important. Please schedule doctor appointments, trips and jobs around our rehearsal schedule. You are allowed to miss 3 rehearsals for emergencies, after that your grade in band will be lowered. If you don't feel like you can commit to the rehearsal schedule you may still be a member as a non-competitive alternate.

## What does it cost to be in the Marching Band?

There is a $\$ 150$ voluntary camp payment. This money pays for instruments, staff, camp lunches and guard equipment. There is also a mandatory $\$ 100$ fee. This money pays for the music workbook, drill workbook, uniform upkeep, show t-shirt and percussion consumables. If these payments present a problem please contact Mr. Vesilind by email.

## Marching Statesmen Uniforms

All members of the ensemble will be issued a uniform which may include a garment bag, waterproof overcoat, jacket, bibber pants, gauntlets, hat, plume, gloves or a custom fitted uniform for colorguard. All members are responsible for their uniforms, including their proper storage at the end of events.

Musicians must provide their own black socks and purchase marching shoes. All marching shoes must be purchased through the band.

Colorguard members must purchase guard shoes through the band.

## Course Description

Prerequisite: Successful audition

Students in this course are part of the representative performing band for the school. Students continue developing as individual musicians and as members of a musical group. They learn intermediate-level technical and ensemble skills necessary for performance. After-school rehearsals and performances are required of all students as an integral part of the course. Marching band techniques and performances are included for interested students but are not required..

## Curriculum Objectives

All students will learn and execute the following: 12 major scales, 3 minor scales in three forms, acceptable tone and intonation, acceptable musical balance as a group, proper care of and cleaning of instruments, and the performance of selected music.

All students will rehearse and perform as a group in concert venues.

## Advanced Band (Wind Symphony) <br> Course Outline <br> Mr. Vesilind: pjvesilind@fcps.edu

## Course Description

Prerequisite: Successful audition; Corequisite: Participation in Marching Band or Fall sports waiver.
Students in this course form the representative-performing band for the school. Emphasis is placed on the sequential development of advanced technical skills and on the study of related literature. Based on successful completion of sequential concepts for each level, students will continue as specified in course level. After-school rehearsals and performances are required of all students as a part of the course. Marching band techniques and performances are included in this course.

## Curriculum Objectives

All students will learn and execute the following: correct marching fundamentals, including correct step size, instrument- and body carriage, forward- and backward marching, lateral slides, flanks, and other basic positions. Students will learn and execute the following musical skills: 12 major scales, 12 minor scales in three forms, acceptable tone and intonation, acceptable musical balance as a group, proper care of and cleaning of instruments, and the performance of selected music, to include music written at an advanced level from every historical era.

All students will rehearse and perform as a group in marching and concert venues.
