EXTRA-DUTY ASSIGNMENT CONTRACT WITH SCHOOL PERSONNEL This contract is entered into by the FAIRFAX COUNTY SCHOOL BOARD, hereinafter referred to as the "School Board, and \_, hereinafter referred to as the "Sponsor". Penelop Bauer The School Board and the Sponsor agree that the Sponsor will perform the following extra-duty assignment subject to the authority of the School Board, under the supervision and Assistant March Band Diretor direction of the Division Superintendent or designee, subject to the Code of Virginia and subject to the following conditions: "Extra-Duty Assignment" means an assignment for which a monetary supplement is received requiring responsibility for any 1. student organizations, clubs, or groups, such as service clubs, academic clubs or teams, student publication and literary groups, testing coordinator, visual and performing arts organizations, or the practice of athletic training by Virginia certified athletic trainers, except those that are conducted in conjunction with regular classroom curriculum or instructional programs. The Sponsor shall perform such pertinent duties during the period of this assignment as are deemed necessary by the School Board and the Division Superintendent or designee, under the supervision and direction of the school principal or designee. 2. The Sponsor shall comply with all applicable laws, Virginia Board of Education regulations, School Board policies and regulations 3. of the Division Superintendent now or hereafter in effect. This contract may be terminated by either party with or without cause by providing reasonable notice in writing to the other party. Any Sponsor may be suspended from the performance of his or her duties at the discretion of the principal prior to the 4. termination of the contract. The School Board agrees to pay the Sponsor \$ 100.00 as monetary compensation, payable in accordance with established payroll procedures. The Sponsor agrees and acknowledges that this employment does not qualify as service toward continuing 5. contract eligibility, does not constitute teaching experience, and does not create any rights of any type in favor of the Sponsor other than the compensation referred to herein. This agreement is for an extracurricular activity sponsorship assignment from August 2014 through June 2015 (ending month and year) commencing August 2014 The School Board shall deduct from the monetary compensation all deductions required by law. 7. Termination of this agreement by either party shall not, in itself, constitute cause for termination of any separate teaching 8. contract between the Sponsor and the School Board. The School Board delegates to the Division Superintendent or designee the authority to initiate and terminate this Agreement, and to take such other actions as may be in the school system's interests in regard to performance under till Engineent. 9.
