Your Honor, the purpose of this letter saddens me but the heartfelt truth within are from a childhood friend who learned an important lesson from Sang. Twenty years have come to past, the memories forged are now table talks at our occasional gatherings. The last time I saw Sang, he looked different in appearance yet radiated the same level of confidence of the Sang I first met in third grade over twenty years ago.
